1. The April meeting of the City Council of the City of Coldstream was called to order by Mayor Starks at 7:10pm.

2. Code Enforcement Issues

a. 4902 Springlet Court - Abandoned Vehicles

Mayor Starks reported that the Blue Dodge and Red Cadillac have not been towed. B. Hodge sent a letter, today, advising the owner that the vehicles will be towed.

b. 5025 Middlesex Drive

There is a red truck on the property that is jacked up with a back wheel missing. G. Stewart will be asked to check on this.
