Gary and Victoria Wadley were in attendance to express concern about the surroundings of the above property which is in disrepair. Dogs are causing a disruption to the neighborhood. Z. Schewe commented that Animal Control has been out and indicated that the dogs are fine. B. Hodge sent a letter to the Dunn's regarding the high grass and debris in the front yard. If the issued are not rectified, the city will cut the grass and clean up the trash at the owner's expense. The Wadley's were advised to contact Metro 311 for Animal Control, and the Health Department to file complaints regarding this property. Also, the neighbors should be calling and filing complaints. The Wadley's were provided the phone number for Metro District Representative, Markus Winkler to have discussions with him regarding the property. G.
