Spring Beautification

The City of Coldstream is diligently working towards being proactive on Code Enforcement violations. However, you are encouraged to contact the city with complaints or concerns. Many times rubbish, mattresses and furniture, or even poor property maintenance can become a neighborhood eyesore. These issues should be called into the city who will forward to the Code Enforcement Officer.

After the complaint has been verified, the offender could receive a Notice of Violation with a date of compliance or a verbal warning. If the violation is not remedied, follow up measures including fines and clean-up costs could be assessed to the property.

Common complaints include:

- Property Maintenance-Debris around the property, broken and hanging shutters and gutters, soffits detaching from the house
- Junk cars
- Parking on the grass or on unapproved surfaces
- Mattresses not bagged in plastic
- Failure to notify sanitation company about furniture
- Excessive growth of vegetation.
- · Household items stacked in carports or driveway
- Failure to remove limbs and branches from yard
- Failure to cut limbs hanging over sidewalk



2018 Property Taxes

The 2018 property Taxes and sanitation fee were due on December 31, 2018. After that date, a 10% penalty and one percent interest are added to the tax bill. To avoid delay in processing your payment, it is requested that you contact the City Clerk to obtain the correct amount due. Letters to delinquent homeowners are being initiated. If payment is not made by the due date, a lien will be placed on the property.
